



Vital Considerations

- Processors are the key link to the consumer market.
- Industrial hemp: the new soybean or the new Emu?
 - Substantial growth and real market (so not Emu)
 - Projected growth a reach?
 - \$22B CBD market by 2022 (source: Brightfield Group LLC)
 - Need to be a little skeptical (Maybe not next soybean?!)
 - Who knows?




\$820 Million U.S. Hemp-Based Product Sales by Category in 2017

2017 Kentucky Processors

- 49 Approved (9 in 2014; 72 in Sept 2018)
- \$7.5 Million Paid to Kentucky Growers
- \$25.6 Million Capital Investments
- 81 Full-time Jobs Created
- \$16.7 Million Gross Product Sales

Location of Kentucky Processors




Preliminary Kentucky Production 2017

| Category | Grain | Fiber | Floral |
|---|--------|--------|--------|
| Growers | 20 | 14 | 112 |
| Acres Planted | 1,227 | 159 | 1,883 |
| Acres Harvested | 826 | 120 | 1,371 |
| Average Yield (Pounds/acre) ¹ | 518 | 2,556 | 1,024 |
| Average Price Per Pound | \$1.70 | \$0.34 | \$7.20 |

Example of North Carolina Facility

- Criticality: 2018 Dec launch, Korent product line, full-spectrum CBD oil drops
- Joint venture with Pyxus International Inc.
- 9 workers in December 2018
- 55,000-square foot facility, forecasting 88 jobs

Processing in Tennessee

- Currently we find a lack of processing in the state
- Contacted all 125 individuals listed by Tennessee Depart of Agriculture as having a processing license
- 34 responses so far:
 - 8 have indicated that the are currently accepting industrial hemp for processing
 - None are very large operations
 - Several are in the process of setting up a processing facility
 - Mostly interested in processing for CBD oil

Kentucky Processing 2018

- KY Department of Agriculture October 18
- 2014 Farm Bill: "agricultural pilot program" means a pilot program to study the growth, cultivation, or *marketing* of industrial hemp

Marketing and Starting

- What is step 1? Involves numerous factors but your market is one of the key elements
- What is step 3? Find a buyer or processor!

I want to grow hemp. Where do I start?

Logical Steps to Enter the Industry

- Determine what type of hemp you want to grow; what fits your farm operation: Grain, Fiber, CBD
- Apply for and obtain a hemp Grower License from Kentucky Department of Agriculture
- Find a buyer/processor for your intended harvest. As a starting point, the 2018 Processor/Handler List is found on the KDA website.
- Locate and obtain legal industrial hemp seeds or transplants (processor will typically dictate what strain you plant)
- Research proper crop production
 techniques before planting the crop



Working with Processor or Buyer

- Start conversion with processor or buyer right away
- Have a contract
- Go over the contract with a lawyer
- Make sure you can meet the required specifications on in the contract
- Critically evaluate incentives

Working with Processor or Buyer

- Don't bet the farm on your operation
 - Best to start small
- If the markets get saturated prices could drop quickly
- Farmer loses everything if the THC of their plant goes higher that 0.3% at anytime (10 in NC last year)

Price: Highly Variable, Quality is Very Important

- \$2-\$7 per CBD %
 - 1000 lbs. of biomass (dried and stemless), with a CBD percentage of 10% and the highest quality cannabinoid spectrum with no contamination-impurities
 - Per acre gross **\$70,000**: [(\$7) x (10% CBD) x (1000 lbs. biomass)]
 - 5% CBD and lowest quality
 - Per acre gross **\$10,000**: [(\$2) x (5% CBD) x (1000 lbs. biomass)]

Do You Due Diligence

- The below is always important but especially so for a new industry
- Find out as much as you can about the principal owners-managers of the operation
 - Years in operation
 - Industry experience
 - Background check

More on Due Diligence

- Just because the processor is working with local officials doesn't mean it is a go!
- The economic development landscape is littered with "groundbreaking failures"
 - Financing can fall through
 - May have been a scam the whole time
 - People are pros at seeking out desperate communities

Cautionary Story: Paducah KY Facility

- HMI Group of Beijing and Kings Royal Biotech announces new hemp processing facility promising 271 jobs posted February 13, 2018
- July 19, 2018, announced plant will not be built
- Could not find further financing and has run out of \$
- Contracted with Kentucky farmers to raise 2,300 acres of hemp for CBD production
- There was no immediate word whether those farmers would be paid.
