I the undersigned hereby affirm that all plants sold or delivered by me will be obtained by growers or firms supplying plants who have been granted official certificates of inspection. I expect to secure plants from the above firms, and attest that I will keep records, invoices, certification, and compliance stamps of the actual sources from which all plants and nursery stock are obtained for a minimum of three years.

**A Plant Certification Inspector will contact you to arrange a time for inspection. No NURSERY or GREENHOUSE certificates may be granted without a current inspection of the facilities.**

Pursuant to Tenn. Comp. R. & Regs. 0080-06-01-.04, any person who grows or keeps plants for sale or distribution must obtain an appropriate license from the Department of Agriculture for each business location where the person grows, propagates, holds or offers to sell or distribute plants on a commercial basis. **All licenses will expire on June 30th of each year.** Fees for the licenses are determined according to the size of the area in which plants are grown or held for distribution, according to the following schedule:

All licenses expire on June 30 following their issuance. License fee for renewal must be remitted to the Department by July 16th following expiration of the license. Non-payment of the license fee by July 16th will result in an additional late charge of 50% of amount owed.
